From Policy to Outcomes: Data in Circularity

Abstract: Public agencies across California and beyond are adopting ambitious zero-waste and circular-economy goals—but many are set without a clear, data-driven understanding of how materials actually move through the value chain. This can lead to misaligned expectations, inefficient investments, and metrics that don't reflect real-world performance.

This session highlights the critical role of data in turning circularity goals into measurable, achievable outcomes. It will unpack common pitfalls, challenge vague “industry-standard” assumptions, and explore how local system differences shape results. Attendees will gain practical insights and more nuanced approaches for developing effective zero-waste goals and circular-economy strategies grounded in actual system conditions.

Leachate Treatment and how PFAS is Removed

Abstract: Chip Benjamin and Jeremy Kroshus from Atmos Technologies will discuss an educational case study on a C and D landfill that successfully transitioned from hauling leachate off-site to a POTW, to treating and cleaning their leachate on-site to meet direct discharge limits. The presentation will highlight several different treatment technologies, the pros and cons of each, and how they were used to meet the discharge objectives, including bio-pre-treatment and separation technologies. The case study is a very good example of the regulators, the engineering consultants, and the leachate treatment provider working together to meet the landfill's needs.
