2024 Exhibitor Agreement Form

AGREEMENT dated _____ 20____, by and between

_____(herein after called "Exhibitor")
(Name of Company to Exhibit)

and the Western Regional Symposium Committee (herein after called "Committee").

FOR GOOD AND VALUABLE CONSIDERATION, it is mutually agreed as follows:

1. The designated product(s) of Exhibitor is (are) solid waste systems, equipment or related items or services.

2. Exhibitor agrees to take, lease, and properly occupy space(s) (numbers(s)) _____ (Hereinafter called the "Space") designated on the official diagram for the 54th Annual Western Regional SWANA Symposium and Equipment show (hereinafter called the "Show") to be held at the Palm Springs Hilton Resort May 20-23, 2024, for the exhibition of the product(s) hereinafter set forth.

3. Exhibitor shall pay for the Space and Committee shall accept the Total Sum of \$ _____ payable as follows: Payment must accompany this contract to guarantee reserved space.

4. For the Total Sum listed in paragraph 3, the Committee will provide the Exhibitor with the space(s) number(s) listed in paragraph 2. Booths 2-36 @ \$1500.00 will include booth piping & draping, one identification sign, a six-foot skirted table and two chairs.

Each booth and table assignment will include ONE FULL SYMPOSIUM REGISTRATION.

Fee for additional booth attendee \$200.00, maximum 1 extra attendee.

5. If Exhibitor does not exhibit the designated product(s) in the Space or otherwise fails to comply with any of the terms of this agreement, the Committee shall have the right, without notice to Exhibitor, to sell or offer the Space for sale at public or private sale and Exhibitor shall pay to committee any deficiency, loss or damage suffered by Committee by reason thereof, including the reasonable expenses and costs incurred. Occupancy of the Space is of the essence of this agreement and should Committee be unable to effect a sale of the Space as herein provided, it shall have the right to occupy or cause the Space to be occupied in such manner as it may deem in the best interests of the Show or cause Exhibitor's name to be placed on the board over the Space, all without releasing Exhibitor from any liability hereunder.

6. All Exhibitors shall be subject to the approval of the Committee. Only the name of Exhibitor may be used over or in the Space or may be included in the printed list of exhibitors and program of the show.

7. In case the Space shall not be available for the uses herein specified due to war, governmental action or order, act of God, fire strikes, labor disputes, or any other causes beyond the control of Committee, this agreement shall immediately terminate and in such event Exhibitor shall and does hereby waive any claim to damages or any other recovery therefore except the return of the amounts paid as rental for the Space, less the pro-rata share which can be allocated to the Space for the actual expenses incurred by Committee in connection with the Show. Should Committee, in its sole discretion, consider it inadvisable to hold the show at the time and place herein provided, Committee may at its option terminate the agreement, return the sums paid by Exhibitor for the Space and there shall be no further liability on the part of either part to the other. Upon written notice to Exhibitor, Committee shall also have the right to change the date and the place where the Show is to be held.

8. Committee will not be responsible for any injury that may arise to exhibitor, its employees or others or for the loss or damage to any material from any cause whatsoever while in transit to or from the building or while in the show whether or not Committee furnishes attendants, guards or watchmen. Exhibitor agrees to hold Committee harmless from any suits, liability or claim from damage or injury, sustained by any person, arising out of Exhibitor's use of the Space and its activities in connection with the Show.

9. The Rules and Regulations provided by the Palm Springs Hilton Resort, hereby are made a part hereof as though fully incorporated herein and Exhibitor shall be bound thereby. Committee shall have the right to interpret, amend and enforce said Rules and Regulation. This agreement may not otherwise be amended except in writing signed by both parties. This agreement constitutes the entire agreement between the parties.

10. This agreement is made in, and shall be construed in accordance with the laws of the State of California.
